IAHS TREASURER'S REPORT to July 2025 IAHS Bureau meeting For Financial Year 1 January–31 December 2024

Change

There were several changes of note in 2024 in relation to IAHS finances.

- Participant Licence Fees were received for the ICCE Symposium and 9th IWRM/14th STAHY/1st EBHE joint meeting. These were higher than budgeted due to insistence from IAHS that full fees are returned from all participants at IAHS-badged meetings. Participant Licence Fees for the IAHS 2022 Scientific Assembly (600 participants) were accrued as are still pending, although they may be resolved soon now that the final PIAHS volume associated with the Scientific Assembly has been published.
- 2) The delayed IUGG 2023 subvention and head tax from the 2023 IUGG General Assembly head tax were received, along with the 2024 IUGG annual subvention.
- 3) Bank interest rates continue to vary in the UK so are difficult to predict, resulting in the receipt of higher than budgeted interest on IAHS accounts. Nevertheless, bank interest received remains a small proportion of income.
- 4) The cost of implementing the new *HSJ* Digest, as well as annual hosting charges and a monthly support contract, meant that the IAHS website costs in 2024 were slightly higher than budgeted.
- 5) IAHS funded the costs associated with travel in 2024 by IAHS officers to the Roorkee Water Conclave, EGU General Assembly, 9th IWRM/14th STAHY/1st EBHE joint meeting workshop, and UNESCO Water meeting in Paris. IAHS Officer expenses were lower than budgeted, mostly due to spending restraint.
- 6) IAHS funded SYSTA awardees to a total of £19,100 in 2024. This is significantly lower than budgeted. Ten awards were budgeted for 2024, and nine awards made. However, the three awards made for the IAHS Academy did not proceed in 2024 due to postponement of the Academy and another SYSTA awardee was not able to secure a visa for travel.
- 7) IAHS administered the grant (\$8500) from IUGG to the 9th IWRM/14th STAHY/1st EBHE joint meeting in Florianópolis, Brazil, in November 2024 to support the participation costs of nine awardees selected by the LOC (2 females from Peru and Mexico and 7 males from Bolivia, Colombia, Chile, India, Peru, Turkey and Uruguay).
- 8) In 2024 the IAHS Ltd Board and IAHS Bureau made a decision to reduce spending to ensure long-term financial stability and maintenance of sufficient reserves in case of a change in income. This approach has been successful, with a surplus of £42,300 for 2024, as a result of lower expenses.

2024 Finances

In summarising our financial position, I refer to the reports of the finances of IAHS for 2024 (see Appendix A, B and C). Appendix A shows the 2024 finances in the format reported to IUGG. Appendix B shows a more detailed breakdown of the IAHS Ltd figures for 31 December 2024, currently being formatted by the IAHS Ltd accountants for submission later in 2025 to Companies House and the Charity Commission for England and Wales. They will be identical to those reported to IUGG (except in GBP sterling rather than euros), and will exclude the remaining unspent funds of the advance payments made to the Secretary General and President Elect to fund their travel on behalf of IAHS. Expenditure by IAHS Officers for 2024 is shown in Appendix C. The Association balance at 31 December 2024 was €636186, compared with €578286 on 31 December 2023¹, producing a 2024 surplus of €57900. This outcome was due to the effective implementation of the decision to reduce spending in 2024, so as to achieve at the most the small deficit budgeted.

The main income sources for IAHS are royalties paid by Taylor & Francis (T&F) for sales of *Hydrological Sciences Journal* subscriptions and online downloads and the annual subvention from IUGG. In 2024, our income from T&F was €246506* (£205490), close to the expected amount after a decrease in 2022, plus individual subscriptions. The other major income source is the annual IUGG subvention, €34439, similar to the 2023 subvention (€33835). Donations are divided into Association donations and Publication donations from T&F associated with *HSJ*.

Our expenditure is mainly on staff salaries, grants and donations (predominantly the IAHS Sivapalan Young Scientists Travel Awards (SYSTA) scheme, WaterNet, and second Latin American workshop in Santiago de Chile in March 2024), the Digital Water Globe, travel by IAHS officers (especially the Secretary General), Bureau costs, office rental and other costs associated with the IAHS Ltd office and communications. In 2024, 9 SYSTA awards were made: 2 for the ICCE International Symposium in Eichstätt-Ingolstadt, Germany, in July, 4 for the 9th IWRM/14th STAHY/1st EBHE joint meeting (one awardee could not attend due to visa issues), and 3 for the first edition of the IAHS Academy. Due to the rescheduling of the Academy for logistical reasons, the latter awards will be carried forward to the IAHS Academy planned in January 2026 in China. More details of the operation of the SYSTA scheme, numbers of applications and awards are given in the separate report to Bureau. In 2024 payments to SMHI for the continuing maintenance and hosting of the IAHS Digital Water Globe totalled €11634* (£9699).

The IAHS provided €9597* (£8000) to WaterNet, which provided partial or full funding for 15 early career African hydrologists from southern Africa to attend the annual WaterNet Symposium held in Maseru, Lesotho, in October 2024. Funding allocated to the IAHS Committee for Africa was used to support an IAHS officer and African early career scientist to attend the EGU General Assembly in Vienna, Austria, in April 2024. Funding was also provided to support a second workshop organised by the Latin American Regional Committee and held in Santiago, Chile, in March 2024 to strengthen water sector stakeholder networks and representation of IAHS in Latin America. Funds were used for the meeting rooms, accommodation and meals, and local transport.

2025 Finances

As reported last year, IAHS has been effective in spending down the reserves accumulated in 2020– 21 during the COVID-19 pandemic to support and accelerate Association activities, in line with its charitable status. New IAHS activities funded in the past few years to support communication, collaboration and engagement include: the Digital Water Globe, Regional Committee support, the development of the HELPING Scientific Decade, the IAHS website relaunch, and the launch of the *HSJ* Digest. IAHS Ltd staff numbers and hours were also increased to enable these increased activities and communications.

Although a small financial surplus was realised in 2024, a cautious financial approach is still required for the next 2 years to ensure that the Association can continue its support for members and make grants into the future, whilst holding sufficient reserves to cover direct and operating costs in the event of an unforeseen decrease in income. The annual IAHS Ltd Board meeting is now held online in

alternate years instead of in-person every year. IAHS Officers use other sources of funding as far as possible for IAHS-related travel. Travel funding for the *HSJ* Co-Editors has been mostly retained to support promotion of the journal that brings in 70–80% of the annual income to IAHS. Similarly, travel funding for the Secretary General has been retained to maintain the profile of and maximise opportunities for IAHS on the international stage.

The priority for maintaining grants is: 1) the SYSTA scheme for early career scientists from financially disadvantaged countries (FDCs); 2) seed corn funding for proposals from regional committees to kickstart activities with a wide regional reach and defined outputs; 3) the Falkenmark Award that takes the form of a travel grant for the awardee to attend the IAHS meeting at which the award is presented; and 4) continuing to develop digital tools to support worldwide collaboration between hydrologists and public engagement.

The 2025 budget as presented in the separate paper by the IAHS Treasurer is deliberately prudent, containing cautious estimates of income and trying to anticipate all expenses. Overall a small deficit is budgeted for 2025 since our expenditure in projected to be greater than last year, due to allocating funding for: 1) the increase in seed corn funding for which regional committees can apply; 2) travel grants for the IAHS Scientific Assembly in October 2025; 3) the in-person *HSJ* Editorial Retreat taking place around the IAHS Scientific Assembly in October 2025; 4) IAHS Ltd staff travel to the *HSJ* Editorial Retreat and the IAHS Scientific Assembly; 5) investment in IAHS Ltd staff training and development to continue an excellent working environment and culture for IAHS.

At the end of June 2025, our funds are on track as the T&F payments and 2025 IUGG subvention have been received.

Reserves Policy

The Reserve and Investment Policy of IAHS Ltd is reviewed annually. Any organisation needs to hold a reserve sufficient to enable it to continue in a poor economic environment. Previously, IAHS Ltd has built up a reserve sufficient to keep the IAHS office and the Association operating for one year assuming no income, in accordance with the recommended best practice for charities. The trustees have adopted a very safe investment policy to protect this reserve for direct and operating expenses of ~€293900* (~£245000), or ~€349700* (~£291500) when grants are included.

At the IAHS Ltd Board meeting in February 2025, the trustees considered the financial situation and agreed a cautious approach to expenditure in the immediate future and to seek additional sources of funding for IAHS. The trustees agreed that reserves funds are maintained in very safe investments, in particular fixed term deposits and bonds with a known interest rate, rather than to lock them into investments with a higher risk and marginally greater return.

Outlook

IAHS has been successful and effective over the past few years in accelerating Association activities in line with its mission and charitable status, particularly in increasing its worldwide reach and communications and collaboration. This acceleration has been supported by spending down on the reserves accumulated during the COVID-19 pandemic. To ensure that the Association can continue its support for members and make grants into the future, it is necessary to maintain a cautious approach towards IAHS expenditure in direct & operating costs and in grants.

Along with the Treasurer, the IAHS Ltd Board and IAHS Management Team review the finances of IAHS quarterly, as well as at year end. Over the next 2–3 years, if circumstances permit, it is anticipated that more grants / investments / seed corn funding could become available, particularly

if (1) additional external funding sources can be secured and (2) IAHS Commissions and Working Groups increase activity in organising IAHS meetings that bring in participant licence fees to help contribute to the long-term financial sustainability of the SYSTA scheme. Since income from publishing *Hydrological Sciences Journal* comprises the majority of IAHS income, It is also important for IAHS that *HSJ* continues to thrive and that IAHS officers and members continue to support it and the co-editors in their endeavours.

The change in IAHS Treasurer from Kate Heal to Kostas Soulis, appointed by Bureau, took place on 1 January 2025. Supported by Claire Lupton, Kate and Kostas have been working together on Treasurer responsibilities in 2025, with Kate leading on 2024 Financial Year reporting and Kostas leading on finances for 2025 and onwards.

Because transactions are made in euros, dollars and other currencies, as well as pounds sterling, IAHS finances are complicated. The work of Claire Lupton in maintaining the IAHS Ltd accounts is hugely appreciated.
